DURING THIS PERIOD, 255 PEOPLE WERE SERVED IN TENNESSEE, SOUTHERN INDIANA, AND NORTHERN KENTUCKY, WITH 88% OF THEM HAVING CONSISTENT AND MEANINGFUL COMMUNITY INVOLVEMENT.
