DISABILITY SERVICES: WE PROVIDE SERVICE AND SUPPORT FOR ADULTS WITH INTELLECTUAL AND DEVELOPMENTAL DISABILITIES THROUGHOUT OUR SERVICE AREA IN KENTUCKY, TENNESSEE, AND CLARK AND FLOYD COUNTIES IN INDIANA. AS ONE OF THE REGION'S LARGEST PROVIDERS OF SERVICES, VOA HAS WORKED DILIGENTLY PARTICULARLY THROUGHOUT THE PANDEMIC TO MAINTAIN THE HIGHEST STANDARDS OF SERVICE WHILE PROTECTING THE HEALTH AND SAFETY OF RESIDENTS. RESIDENTS OF OUR COMFORTABLE AND WELCOMING HOMES RECEIVE 24-HOUR MEDICAL CARE AND THE VOA MID-STATES TEAM WORKS TO INTEGRATE RESIDENTS INTO THEIR COMMUNITY. OTHER PROGRAMS FOCUS ON VETERANS, INCLUDING THE HOMELESS VETERANS REINTEGRATION PROGRAM AND SUPPORTIVE SERVICES FOR VETERANS' FAMILIES, BOTH OF WHICH FOCUS ON COMPREHENSIVE HOUSING SOLUTIONS FOR VETERANS AND THEIR FAMILIES. WE ALSO OPERATE THE EVICTION PREVENTION PROGRAM AND FAMILY STABILIZATION PROGRAM FOR FAMILIES AT RISK OF BEING UNHOUSED, AND SERVES THE HOUSING NEEDS OF PEOPLE WITH AIDS WITH THE HOUSING OPPORTUNITIES FOR PEOPLE WITH AIDS (HOPWA) PROGRAM. WE ALSO OPERATE SENIOR HOUSING FACILITIES IN LOUISVILLE, MEMPHIS AND THE KNOXVILLE AREA, WITH MORE THAN 300 UNITS OF HIGH-QUALITY, AFFORDABLE HOUSING.
